DENTAL SUPPLIES AND EQUIPMENT (2) MILK PRESERVE PROCESSED (3) FOOD COMMODITIES
(4) SALT (5) SUGAR (6) CLOTHING OR TEXTILES COMMONLY USED IN MANUFACTURE
OF CLOTHING (7) HOUSEHOLD TYPE FURNITURE EXCEPT FROM MANUFACTURERS OR DEALERS
STOCKS (8) CHARCOAL (9) GENERAL PURPOSE VEHICLES INCLUDING PASSENGER OR
ACCESSORIES TOOLS SPARE PARTS TIRES AND TUBES (10) PETROLEUM PRODUCTS
