Tec 4 Francis D Leahy, 31241257, 256, 797th Ord (M) Co is placed on DS, WP to the Ordnance School, Aberdeen, Maryland, so as to arrive on 19 Feb 44 to rpt to the Comdt thereat for the purpose of attending the Wheeled Vehicle Classis Course. Upon completion of course (approx 8 wks) EM will return to proper sta. By being temp dependents are not auth to accompany EM. Travel by privately owned conveyance is not auth. EM will be required to live in place or places designated by school authorities. S/R and allied papers, including WD AGO Form 20, will physically accompany EM in sealed envelope and be delivered to Comdt upon arrival. Clo taken will be as prescribed in par 4b AR 615-40, 24 Apr 43; especially sufficient coveralls, field shoes and leggings to last while in attendance at the school. IGF. In accordance with AR 35-4520 the FD will pay in adv monetary alws in lieu of rations at the rate of \$1.00 per meal for four (4) meals to one (1) person for going journey. In accordance with par 4d, Change 1, WD Memo W350-26-43, 10 June 43, the CG, Third Serv Comd will arrange for payment of monetary alws in lieu of rations at the rate of \$1.00 per meal for four (4) meals to one (1) person for return journey.
